SWTR: any failure to adequately treat drinking water to meet the requirements of the Surface Water Treatment Rule.

NO3: any system which exceeded the MCL for Nitrate (10mg/L)

DBPs: any system which exceeded the MCL for Disinfection Bi-Products (TTHMs: .08 mg/L; HAA5s: .06 mg/L)

Arsenic: any system which exceeded the MCL for Arsenic (.05 mg/L in 2005)

Lead: any system that exceeded the 90th percentile lead action level (.015 mg/L)

Copper: any system that exceeded the 90th percentile copper action level (1.3 mg/L)

WS -- Water System

Community WS -- a water system which serves 25 or more year round residents or has 15 or more connections.

Nontransient noncommunity WS -- a water system which serves 25 or more of the same users at least 6 months out of the year, but the users are not year round residents. For example: schools and work sites .

Transient WS -- a transient noncommunity water system which serves at least 10 people a day for at least 60 days out of the year. Only those serving 500 or more persons a day are included in the benchmarks. For example: restaurants, parks, and campgrounds.

2004 Benchmark: 95% of Oregonians served by public water systems were served water that met the benchmarks.

(3,280,017 Oregonians were served by public water systems in 2004; 156,793 were served water that failed to meet the benchmarks)

2003 Benchmark: 94.6% of Oregonians served by public water systems were served water that met the benchmarks.

(3,053,034 Oregonians were served by public water systems in 2003; 163,492 were served water that failed to meet the benchmarks)

2002 Benchmark: 91.7% of Oregonians served by public water systems were served water that met the Benchmarks.

(3,004,030 Oregonians were served by public water systems in 2002; 247,865 were served water that failed to meet the benchmarks)

2001 Benchmark: 93.4% of Oregonians served by public water systems were served water that met the Benchmarks.

(2,956,335 Oregonians were served by public water systems in 2001; 196,127 were served water that failed to meet the benchmarks)
