On June 16, 2014, the Oregon Health Authority, Center for Health Protection, Radiation Protection Services (RPS) issued a Notice of Violation and Proposed Imposition of Civil Penalty pursuant to Oregon Revised Statute ORS 431.950; Oregon Administrative Rules (OAR) 333-103-0025, 333-119-0020, 333-119-0140, and 333-124-0010 proposing to impose a civil penalty against **Tan Republic- Oregon City** in the amount of **\$33,800.00** for violations of Oregon Administrative Rules (OARs) listed in the Notice. The Notice offered **Peter Lamka**, the owner of Tan Republic- Oregon City, an opportunity for a hearing, if requested within 20 days of service of the Notice. The Notice designated the relevant portions of RPS' file on this matter, including all materials submitted by Peter Lamka, as the record for purposes of default. Peter Lamka did not request a hearing.

NOW THEREFORE, after considering the relevant portions of RPS' file relating to this matter, RPS enters the following Order.

**FINDINGS OF FACT**

1. Tan Republic- Oregon City consists of a tanning facility at 1701 Beaver Creek Road, Oregon City, and has a total of 13 tanning device(s).

2. On January 1, 2013, Tan Republic- Oregon City was required to pay to RPS a \$100 registration fee per tanning device, for a total of \$1,300 in registration fees. OAR 333-119-0020 and 333-103-0025.
3. Two payment notices were mailed to Peter Lamka at the address of record. On November 26, 2013, an Informational Bulletin advising registrants of Electronic Payment to pay outstanding registration fees was mailed to the address of record.
4. To date, RPS has not received registration fees.

### ULTIMATE FINDINGS OF FACT

Tan Republic- Oregon City did not pay its 2013 registration fees.

### CONCLUSION OF LAW

Tan Republic- Oregon City violated OAR 333-103-0025 by failing to pay its 2013 registration fees.

### ORDER

As authorized by ORS 431.950, Tan Republic- Oregon City shall pay a civil penalty of **\$33,800.00**, calculated as follows for violations of OAR 333-103-0025 and OAR 333-142-0010(8):

13 devices x \$100 registration fees = \$1,300

**Proposed Civil Penalty Amount: \$33,800.00**

1. In addition to paying a civil penalty, Tan Republic- Oregon City shall pay the 2013 registration fees of \$1,300. **Amount owed to the State: \$35,100.00**

2. Failure to comply with this Order may subject Tan Republic- Oregon City to further civil penalties.
