RE: IMPORTANT INFORMATION - Tanning rules update

In the interest of public health and safety, the Public Health Division is committed to minimizing health effects by protecting the public and the employee when operating tanning devices. The Radiation Protection Services (RPS) employs Health Physicists to inspect businesses that expose the consumer to non-ionizing radiation following Oregon Administrative Rules (OAR) Chapter 333 Division 119.

This informational Bulletin is to inform tanning registrants and operators that rule changes have occurred effecting tanning devices for commercial use, Department approved training courses, and rule revisions that effect tanning operators.

TANNING OPERATOR TRAINING:

As outlined in **OAR 333-119-0080(3)** *On or after July 1, 2011, all operators of registered tanning devices must successfully complete a Department approved tanning training course in the State of Oregon prior to commencement of tanning operations.*
