




## Screening trends: 2012-2015






## Screening by birth facility types: 2012-2015




# Screening rates among screening birth facilities: 2013-2015






## Out of Hospital Screening Rates: 2013-2015








## El Enrollment Status: 2014 (prelim.)







## Reason Not Enrolled in El: 2014 (prelim.)








# Demographic Characteristics: Race/Ethnicity








# Demographic Characteristics: Mother received WIC at delivery







# Demographic Characteristics: Mother's marital status



# Demographic Characteristics: Mother's age








# Demographic Characteristics: Mother's education
