Subject: State-wide Presentation on OMMP Online Inventory Reporting System

The Oregon Medical Marijuana Program (OMMP) would like to inform registrants of new reporting rules that took effect on March 1, 2016. OHA rules OAR 333-008-0630, 333-008-1248 and 333-008-1830 require growers, dispensaries and processors to report to OMMP information regarding the production and transfer of medical marijuana.

**The first online submission is due no later than July 10, 2016, for transfers that occurred during June 2016.**

**Subsequent reporting is due on a monthly basis, no later than the 10<sup>th</sup> of each month.**

During May and June OMMP staff will provide several in-person state-wide presentations on the OMMP inventory reporting system. The presentations will provide guidance and training on how to use the system, what information is required to be reported, and clarification on transfer rules. The presentations will also show growers how to register online. Each presentation will last about 45 minutes with time afterward to assist growers with setting up online accounts. The presentations and trainings will occur on the following dates and locations:
