On November 18, 2010, the Oregon Department of Human Services, Public Health Division, Office of Environmental Public Health, Radiation Protection Services (RPS) issued a Notice of Violation and Proposed Imposition of Civil Penalty pursuant to Oregon Revised Statute ORS 431.950; Oregon Administrative Rules (OAR) 333-119-0020 and 333-124-0010 proposing to impose a civil penalty against Nail Designs/Sun Palace in the amount of **\$100** for violations of Oregon Administrative Rules (OARs) listed in the Notice. The Notice offered Tye Dodson, an opportunity for hearing, if requested within 20 days of service of the Notice. The Notice designated the relevant portions of RPS' file on this matter, including all materials submitted by Mr. Dodson, as the record for purposes of default. Mr. Dodson did not request a hearing.

NOW THEREFORE, after considering the relevant portions of RPS' file relating to this matter, RPS enters the following Order.

FINDINGS OF FACT

1. Nail Designs/Sun Palace consists of a tanning facility at, 1112 Progress Road, Suite 111, Medford, and has a total of 9 tanning devices.
2. On April 20, 2010, Nail Designs/Sun Palace was inspected by an RPS staff member. During the inspection, Nail Designs/Sun Palace was found to be in violation of a number of administrative rules governing tanning devices and facilities. The violations were cited in the inspection report form dated April 20, 2010, that is incorporated by reference.

3. Nail Designs/Sun Palace or a member of its staff was instructed to respond in writing within 30 days of the inspection with corrective action.
4. Nail Designs/Sun Palace or a member of its staff was informed that if no response was received within 30 days civil penalties would be assessed as authorized by ORS 431.950 and OAR 333-124-0010.
5. On December 9, 2010, RPS received a response to 333-119-0080(1). However, 333-119-0100(3) was not addressed.

ULTIMATE FINDINGS OF FACT

Nail Designs/Sun Palace is operating as a tanning facility in violation of ORS 431.940 and OAR 333, Divisions 119 and 124.

CONCLUSION OF LAW

1. Nail Designs/Sun Palace violated rules governing tanning facilities as documented in the April 20, 2010 Inspection Report which has been incorporated by reference, has not corrected such violations, and is subject to civil penalties.
2. Pursuant to ORS 431.950 and OAR 333-124-0010, a civil penalty shall be imposed against Nail Designs/Sun Palace totaling **\$100**.
3. The civil penalties are calculated as follows for violations of OAR 333-119:

333-119-0100 (3)	3	\$100	x 1	= \$100

Proposed civil penalty amount = **\$100**

4. Failure to comply with this Order may subject Nail Designs/Sun Palace, to further civil penalties.

ORDER

Nail Designs/Sun Palace is ordered to pay a civil penalty in the amount of \$100.
