On June 6, 2012, the Oregon Health Authority, Center for Health Protection, Radiation Protection Services (RPS) issued a Notice of Violation and Proposed Imposition of Civil Penalty pursuant to Oregon Revised Statute ORS 431.950; Oregon Administrative Rules (OAR)333-103-0025, 333-119-0020, 333-119-0140, and 333-124-0010 proposing to impose a civil penalty against Tan Republic in the amount of **\$540.00** for violations of Oregon Administrative Rules (OARs) listed in the Notice. The Notice offered Ryan Reeves, the owner of Tan Republic, an opportunity for hearing, if requested within 20 days of service of the Notice. The Notice designated the relevant portions of RPS' file on this matter, including all materials submitted by Mr. Reeves, as the record for purposes of default. Mr. Reeves did not request a hearing.

NOW THEREFORE, after considering the relevant portions of RPS' file relating to this matter, RPS enters the following Order.

**FINDINGS OF FACT**

1. Tan Republic consists of a tanning facility at 2160 NW Burnside Street, Portland, and has a total of 6 tanning devices.

2. On January 1, 2012, Tan Republic was required to pay to RPS a \$100 registration fee per tanning device, for a total of \$600.00 in registration fees. OAR 333-119-0020; 333-103-0025.
3. Mr. Reeves was sent, to his address of record, two payment notices regarding unpaid registration fees. In addition, the Department of Justice (DOJ) sent Mr. Reeves a letter advising him of potential civil penalties for failure to pay the outstanding registration fees within 10 days of the dated DOJ letter.
4. To date, RPS has not received any registration fees.

### ULTIMATE FINDINGS OF FACT

Tan Republic has not paid its 2012 registration fees.

### CONCLUSION OF LAW

Tan Republic violated OAR 333-103-0025 by failing to pay its 2012 registration fees.

### ORDER

As authorized by ORS 431.950, Tan Republic shall pay a civil penalty of **\$540.00**, calculated as follows for violations of OAR 333-103-0025 & OAR 333-142-0010(8):

6 devices x \$100 registration fees = \$600.00

1. In addition to paying a civil penalty, Tan Republic shall pay the 2012 registration fees of \$600.00.

2. Failure to comply with this Order may subject Tan Republic to further civil penalties.
