On March 18, 2013, the Oregon Health Authority, Center for Health Protection, Radiation Protection Services (RPS) issued a Notice of Violation and Proposed Imposition of Civil Penalty pursuant to Oregon Revised Statute ORS 431.950; Oregon Administrative Rules (OAR) 333-103-0025, 333-119-0020, 333-119-0140, and 333-124-0010 proposing to impose a civil penalty against **Ja Makin Me Tan** in the amount of **\$1,365** for violations of Oregon Administrative Rules (OARs) listed in the Notice. The Notice offered **Kimberly Lewis**, the owner of Ja Makin Me Tan, an opportunity for a hearing, if requested within 20 days of service of the Notice. The Notice designated the relevant portions of RPS' file on this matter, including all materials submitted by Kimberly Lewis, as the record for purposes of default. Kimberly Lewis did not request a hearing.

NOW THEREFORE, after considering the relevant portions of RPS' file relating to this matter, RPS enters the following Order.

FINDINGS OF FACT

1. Ja Makin Me Tan consists of a tanning facility at 26737 SE Stark Street, Troutdale, and has a total of 5 tanning device(s).

2. On January 1, 2013, Ja Makin Me Tan was required to pay to RPS a \$100 registration fee per tanning device, for a total of \$500 in registration fees. OAR 333-119-0020; and 333-103-0025.
3. Ms. Kimberly Lewis was sent, to her address of record, two payment notices regarding unpaid registration fees and on March 18, 2013 an Enforcement Bulletin advised her of potential civil penalties for failure to pay the outstanding registration fees within 10 days of the dated Enforcement Bulletin.
4. To date, RPS has not received any registration fees.

ULTIMATE FINDINGS OF FACT

Ja Makin Me Tan has not paid its 2013 registration fees.

CONCLUSION OF LAW

Ja Makin Me Tan violated OAR 333-103-0025 by failing to pay its 2013 registration fees.

ORDER

As authorized by ORS 431.950, Ja Makin Me Tan shall pay a civil penalty of **\$1,365**, calculated as follows for violations of OAR 333-103-0025 & OAR 333-142-0010(8):

5 devices x \$100 registration fees = \$500

In addition to paying a civil penalty, Ja Makin Me Tan shall pay the 2013 registration fees of \$500.

1. Failure to comply with this Order may subject Ja Makin Me Tan to further civil penalties.
