The Oregon Health Authority, Radiation Protection Services (RPS) is charged with protecting the health and safety of all Oregonians from unnecessary radiation exposure. It is essential that all registrants comply with Oregon Administrative Rules (OAR) relating to tanning facility operations which minimizes health risks to workers, clients, and the public.

On July 25, 2014, the Oregon Health Authority, Public Health Division, Center for Health Protection, Radiation Protection Services (RPS) issued a Notice of Violation and Proposed Imposition of Civil Penalty pursuant to Oregon Revised Statute (ORS) 431.950; Oregon Administrative Rules (OAR) 333-119-0020 and 333-124-0010 proposing to impose a civil penalty against Tan Republic Oregon City in the amount of **\$8,125** for violations of Oregon Administrative Rules (OARs) listed in the Notice. The Notice offered Peter Lamka an opportunity for a hearing, if requested within 20 days of service of the Notice. The Notice designated the relevant portions of RPS' file on this matter, including all materials submitted by Peter Lamka, as the record for purposes of default. Peter Lamka did not request a hearing.

NOW THEREFORE, after considering the relevant portions of RPS' file relating to this matter, RPS enters the following Order.

**FINDINGS OF FACT**

1. Tan Republic Oregon City consists of a tanning facility at 1701 Beavercreek Road, Oregon City, and has a total of 13 tanning devices.
2. On June 6, 2014, Tan Republic Oregon City was inspected by an RPS staff member. During the inspection, Tan Republic Oregon City was found to be in violation of a number

of administrative rules governing tanning devices and facilities. The violations were cited in the inspection report form dated June 6, 2014, that is incorporated by reference.

3. Tan Republic Oregon City or a member of its staff was instructed to respond in writing within 30 days of the inspection with corrective action.
4. Tan Republic Oregon City or a member of its staff was informed that if no response was received within 30 days civil penalties would be assessed as authorized by ORS 431.950 and OAR 333-124-0010.

### ULTIMATE FINDINGS OF FACT

Tan Republic Oregon City is operating as a tanning facility in violation of ORS 431.940 and OAR 333, Divisions 119 and 124.

### CONCLUSION OF LAW

1. Tan Republic Oregon City violated rules governing tanning facilities as documented in the June 6, 2014 Inspection Report which has been incorporated by reference, has not corrected such violations, and is subject to civil penalties.
2. Pursuant to ORS 431.950 and OAR 333-124-0010, a civil penalty shall be imposed against Tan Republic Oregon City totaling \$8,125.
3. The civil penalties are calculated as follows for violations of OAR 333-119:

4. Failure to comply with this Order may subject Tan Republic Oregon City to further civil penalties.

ORDER

Tan Republic Oregon City is ordered to pay a civil penalty in the amount of **\$8,125**.
