Subject: Phase-out of Oregon WIC Fruit & Veggie (blue) Vouchers

The Oregon WIC Program's switch from paper vouchers to an electronic benefit solution is underway! Our statewide "eWIC" roll-out to WIC-authorized grocery stores and pharmacies began in January. These locations will be accepting eWIC cards statewide by mid-April, 2016.

As eWIC phases in and paper vouchers phase out, the blue Fruit & Veggie Vouchers (FVV) will also dwindle in circulation through June, 2016. You may continue to transact FVVs as long as they are out there. However, since they will not be available after this season, WIC will terminate your contract to accept the blue FVVs, effective December 31, 2016.

Once Oregon WIC is done with eWIC roll-out to grocery stores and pharmacies, we will explore the feasibility for farmers to accept eWIC transactions wirelessly. While a couple of states have piloted this technology, nothing sustainable has yet been developed.

**This change will not affect your participation in the Farm Direct Nutrition Program (FDNP) for seniors and WIC families.** These are the green \$4 checks that are good between June 1 and October 31 every year. FDNP checks will remain a paper benefit for the foreseeable future. Look for the annual March mailing from the Oregon Department of Agriculture!
