

Less than Ideal PUM

- Started out in D.C.
- Compliant
- But fever early in process
- D.C. LHD didn't want to deal with him
- Fortunately fever resolved over night



Anxiety Producing PUM

- First one – low risk BUT
- Hard to track down – traveling between California towns via train
- Had to establish contact with local LHD's during travels
- Medical Officer at CLHD struggled
- Pretty relaxed about reporting in and returning calls

Anxiety Producing PUM

Part II

- **Person at some risk**
- **Had treated Ebola patients and handled the deceased**
- **Out of cell range**
- **Checked in 60% of time**
- **7 incidences no face time (days 8 and 9)**

Additional Stressor

- Hospital wanted names of PUMS – were frustrated by PH lead re: Ebola
- Agreed to let them know when someone was under monitoring but provided no identifying info

Observations

- Email/texting best way to communicate followed by phone and skype
- Ideal PUMs – fun/no stress
- Anxiety producing PUMS – stressful, frustrating, a bit scary

Lessons Learned

- Emotionally detach – do the job but don't feel so personally responsible
- Remain calm
- Call on Health Officer sooner if compliance looks problematic
- Let go of judgement – everyone's doing the best they can
